

# TERMS AND CONDITIONS “DECK EXPERIENCE” PROMOTION

## Promotional Period

1. The promotional period (“**Promotional Period**”) during which participants are entered or are eligible to enter the Promotion commences at 12:30pm Thursday 9<sup>th</sup> November to 1am Tuesday 19<sup>th</sup> December 2023.

## Eligibility
